- 1. Part of the reason for the PSA looking at this area is the work being done by the CMA on "loyalty penalties" and the problem of hidden "auto-renewals". However, this work is not intended to be looking at ongoing subscriptions that are set-up by the consumer and have clear terms with an ongoing mandate. There is no loyalty penalty or auto renewal in charitable donations since supporters are not signing it up for a fixed period, they can opt-out at any point and their donation amount is never increased unless **instructed by the donor.** The notion of a loyalty penalty or fixed period is alien to a donors' understanding of the relationship they have entered into with a charity, which is an ongoing gift until such time that they choose to cancel it. There is no autorenewal.
- 2. The existing mechanic for charity subscriptions is very clear at sign up and is clear on how to cancel. When supporters sign up to a regular gift via PSMS they receive messages as covered in the existing Special Condition for Recurring Donations. This includes a double opt-in at sign up. Each month the supporter then receives two messages, the first before their donation is due giving them the option to SKIP and a receipt for their donation the following day, assuming they did not SKIP. The process is transparent and the supporter is fully aware of the fact that they are donating each month and have the opportunity and details to stop their donation at any time.
- 3. If the CMA were to introduce any requirement that went beyond "auto renewals" and covered all subscriptions then this requirement would apply to all regular giving through all payment mechanics. There is therefore no need for the PSA to require this for PSMS payments in the meantime. Instead, the PSA should wait for any changes from the CMA and then align their code accordingly. Making changes that are not mirrored in other payment methods will cause confusion in the market place amongst donors, especially as it is introducing a concept that does not make sense in charitable giving.

- 4. There are very low levels of complaint in charity PSMS, both with single and regular donations. There are no known complaints or issues with recurring donation services continuing. There have been approximately 700,000 supporters signed up to subscription PSMS since 2012 and in that time there has never been a single complaint about a subscription period not coming to an end. As this is not a transaction relating to the delivery of a service with a set time period, it is the expectation of the donor that it continues until they cancel and the cancelation mechanic is very transparent and easy to exercise.
- 5. The supporter's expectation is that they will continue to donate unless they take action not to (ie to skip a month). It will be counter-intuitive to supporters to receive additional messages asking them to take action in order to continue a service, when their expectation is that it was ongoing in the first place. Donors are likely to view messages as spam and be concerned that by responding they will be setting up a second gift and double billed. This is likely to create confusion and damage the credibility and trustworthiness of SMS marketing.
- 6. Sending a message requiring re-optin could constitute marketing and breach GDPR for most donors that have not consented. There is therefore no mechanism for those donors to continue the subscription that they wanted to give to in the first place, it would create a misleading default cancellation that the donor did not want or agree to, having been told initially that their donation would continue until they choose to stop it.
- 7. The current proposal is impractical and could not work. It requires a double opt-in to be captured every 12 months. For most regular givers, only a mobile number is held, so this requirement would involve sending supporters an SMS asking them to reply YES in order to continue their donation, and if they do so, then sending an additional message asking them to reply YES a second time for double opt-in.
- 8. Any change is likely to have an outsized impact on charities. Unlike a commercial product

	or service that would end as a result of inaction from the consumer, for charity donors there is no impending need for the consumer to re-opt in. They will not experience any loss of 'service' as they are not receiving any product or service and as a result inertia will affect any re opt-in process.
	9. Charities are dependent upon subscriptions for their SMS fundraising. It takes over 12 months for a charity to recoup its investment on recruiting a donor. These changes would destroy the charity subscription market and wipe out millions of pounds for charities. Marginal negative changes in performance would make the fundraising model unviable. By making these changes the PSA would be needlessly reducing charity income and removing a sector from the PSMS market which has no consumer issues or complaints in this area. It is a solution in search of a problem that will have profound impacts for charities and the broader market.
	10. The loss of highly trustworthy and reputable charity subscriptions in the PSMS market is likely to have a more negative effect on the broader mobile payments market. The PSA should focus its efforts on markets and bad actors and ensure existing rules are being followed with clear directions on how to cancel services. If there are issues in other markets then they should be encouraged to mirror the approach taken by charities.
